

PRESS RELEASE

The Foundation for Amateur Radio, Inc. a non-profit organization with headquarters in Washington, D.C., plans to award nine scholarships for the academic year 1982-1983. The Foundation, composed of fifty local area amateur radio clubs, fully funds two of these scholarships from the proceeds of the Gaithersburg (MD) Hamfest. It administers, without cost to the donors, two scholarships for the Quarter Century Wireless Association and one each for the Richard G. Chichester Memorial, the Radio Club of America, the Young Ladies' Radio League, the Edmund B. Redington Memorial and the Amateur Radio News Service. The last named award is new this year.

Radio Amateurs holding at least an FCC General Class License or equivalent may compete for one or more of these awards if they plan to pursue a full-time course of studies beyond high school and are enrolled or have been accepted for enrollment in an accredited university, college or technical school. The scholarship awards range from \$300 to \$900, with preference given in some of them to residents of specific geographical areas or the pursuit of certain study programs.

FROM W5YI REPORT

PENNA. HAM GETS STATE TOWER LAW INTRODUCED

Legislation introduced into the Pa. House of Representatives seeks to amend Public Law 805, No. 247. This law, also known as the Pa. Municipalities Planning Code, entitles certain cities, boroughs, incorporated towns, townships and counties to "Plan their development and to govern the same by zoning, subdivision and land development ordinances..." The new amendment would specifically exempt amateur radio antennas and towers from inclusion.

It all started back in Spring 1981 when Robert N. Wilderman, K3SRO, of Lansdale, Pa. was sued by a local real estate developer to dismantle and take down his 50 foot tower and 3 element yagi beam. Bob had a building permit to put up the tower, but a deed restriction in his subdivision (which he did not know was there "in the fine print") barring antennas which protrude more than 15 feet above the roof. Wilderman felt he was being singled out for enforcement since 35 or 40 other covenant violations also existed in his Meadow Glen tract.

While changes in the state law will have no affect on privately entered into agreements, it is refreshing to see antenna and tower laws being introduced which are advantageous to the radio amateur. Such is usually not the case. The new Section 603.1 of Public Law 805, if adopted, will give amateurs a "Bill of Rights" in the erection of antennas and towers.

A LOOK AT SMOOTHED NUMBERS By John B. Power, W2AXU

Sunspot number records go back many years, to naked eye accounts by Oriental observers as early as the fourth centruy B.C. However, standardized records have only been kept by e Zurich Solar Observatory since 1749.


Solar Flux data is a new means of observing the Sun's activity. Rather than visually counting the Sun's spots, the Sun surface is scanned by radar techniques at 2800 MHz and a number known as the Solar Flux is determined. These daily numbers have been available since 1947.

Sunspot and Solar Flux numbers are provided daily. These daily numbers are averaged monthly and that number is known as the Monthly Mean. The Monthly Mean is applied to a formula and a 12 month running smoothed number emerges. It is the smoothed Sunspot number, plotted over a long period of time, which exhibits the well-known solar cycle variation, and which is used to define the Sunspot cycle.

Below is the curve of the smoothed Sunspot numbers plotted against the smoothed Solar Flux numbers from January 1979 to August 1981 for Sunspot numbers and May 1981 for Solar Flux numbers.

It is interesting to note the similarity of the curves to March 1980. From that point, the Solar Flux curve has a mind of its own and goes off by itself.

The Solar Flux probably being a truer measure of solar radiation (that is, radiation that causes the effect noted on radio propagation), the anomaly noted in the Solar Flux curve could explain why six meter propagation was so extremely good during the months following March 1980, and including the Fall of 1981 and Winter of 1982. If the trend continues, six meter propagation may still be good in the Fall of 1982. We won't be able to make a comparison until the Summer of 1983 when the figures are available.



W5YI REPORT CONTINUED

No longer will Pennsylvania cities be allowed to outlaw or restrict them by zoning ordinance. The new section specifically states...."No zoning ordinance shall exclude or restrict the erection, location or height of an amateur radio antenna, or the tower supporting such antenna. An ordinance may regulate the construction or maintenance of an antenna tower, but only to the extent it is necessary to protect life or property."

The bill will take effect in six months after passage and could set a precedent for other states to follow. It is currently being considered by the Pennsylvania Committee on Local Government. Bob Wilderman, K3SRO, contacted his state representative (Benjamin H. Wilson) to get the proposal written and introduced as a state bill. K3SRO is also working on another bill that will also help amateurs and property owners alike. This bill requires all deed restrictions (written in plain English) to be given to a home buyer before any deposit is placed on any property to be purchased. This way, the buyer is fully aware of any existing covenants before any funds are expended. While it may too late for him, it will save other amateur radio operators from the anguish that Bob has gone through.

U.S. DEPARTMENT OF COMMERCE, National Oceanic and Atmospheric Administration Dear Colleague:

The President's FY 1983 budget, submitted to Congress on Feb. 8, 1982 contains a decrease which may have an impact on you as a user of the services of NOAA's Space Environment Laboratory (SEL) and its Space Environment Services Center (SESC). Specifically, the budget calls for a reduction of NOAA funds for solar-terrestrial reserach and services of \$3.1 M and 34 positions, relative to the FY 1982 levels. At the proposed level of support, it would not be possible to carry on many of the present activities of SEL, in particular, all space-weather research and related systems development would have to be terminated when the new budget is implemented.

The planned procurement of the new computer-based, real-time data system (SELDADS II) would not take place. Real-time, solar-terrestrial services currently provided by SESC would have to be curtailed during FY 1983. These services include, for example, 24-hour/day alerts and forecasts, the WWV broad-casts of the geophysical alerts, and he weekly "Preliminary Report and Forecasts of Solar Geophysical Data." The primary goal of the Laboratory in FY 83 would be to maintain a viable real-time, solar-terrestrial data base, as the necessary foundation for remaining and future services. Only a minimal level of funds and personnel would be available for this purpose.

We will be discussing the impact of the proposed budget with the major users of the services to determine if they can contribute to continuing the most essential services, or if this function can be picked up by another agency. If these arrangements cannot be made, then we face the possibility of phasing out the present services as outlined above.

SEL would appreciate comments from its users about the impact of the reductions of services outlined above. Additional comments about the minimum level of services required by users will be helpful in establishing the service priorities during FY 1983.
