

## NEW PRODUCTS OF INTEREST TO HAMS By Lyn, W3NSI

- 1. DENTRON SWR POWER METER: The New Dentron S-2 covers 160-2 meters and uses two meters, one to read SWR, and the other relative power. The RF power from the rig operates an on the air indicator on the front panel. Meters are illuminated by 12 VDC. Price \$39.95 Dentron Radio Co., 2100 Enterprise Parkway, Twinsburg, Ohio 44087.
- 2. TEN METER FM TRANS/REC: The Comtronix 10 M FM-80 covers two sets of 40 channels in the range 28.91 29.7 Mhz Output is 10 watts with all 80 channels being PLL Freq. Synth. Units operate from 12 VDC and are about the size of the current CB rigs. Spacing between all (simplex only) channels is 10 Khz. Price \$269. 3233 F Coffey Lane, Santa Rosa, Cal. 95401
- 3. HICKOK LX 303 VOM: The new LX303 is a 3 1/2 digit VOM, using a liquid crystal 1/2 inch readout. Unit uses 19 ranges to check DC/AC volts, DC current, and Res. Fower is supplied by a 9 volt radio battery rated at 200 hours of operation. Max DC voltage is 1000, max current to 100 ma. Resistance readings can be used to 20 mags. Price \$74.95.

## VHF/UHF REPORT By Joe, W2EIF

This report covers the period March 15 to April 19,1979. The six meter band has yielded some dramatic F2 openings, but these are mostly South America to Japan or West Coast to Japan. The East Coast has not been fortunate with respect to the 50 Mhz spectrum. There have been a few lucky contacts, notably an opening in the AM from SNJ to South America. W2BN worked an Argentine station with very strong signals noted. The same stations were much weaker in N.N.J.

There was quite a bit of auroa activity during the period March 25 thru April 3. On March 25 the aurora was good thru 432 Mhz and covered the period 7 to 10 p.m. local time. March 27 and 28 there were short openings in the early evening hours. March 29 produced an aurora lasting from 12 noon to 8 p.m. with the usual signals VET to 9th call area heard here with good signals on 6 and 2. April 1 yielded a short aurora on 6 and 2 but was finished by 8:30 p.m. VE3, Ohio, Mich. and Ill. were heard and worked.

April 3 produced the best aurora session this season with signals on 50 Mhz through 432. Stations were worked from Neva Scotia to Iowa, and the VE boys were working 4's down as far as Tenn.

The period April 4 to 19 has not been productive for any unusual propagation as far as the East Coast is concerned. There does seem to be activity almost nitely at 144.2 Mhz and thereabout.

W2BN, Dave, will journey to Cuba (Quatenamo Bay) June 4 thru the 12th and will operate 50 Mhz from there thru the contest weekend. He will be using the call KG4BN. He may go to VPI land later. Dave furnished a 50 W AM rig to C5ADK who is expected to be on by 4-20 from Gambia. There is a new beacon planned for NNJ for six meters. The rig will be attended at first using 50W on 50.07 CW. The calls will be N2CG and WB2TFH.

TWENTY YEARS OF AMATEUR RADIO

C.B. DESOTO

QST MAY 1934

In 1914 history began again.

It is January. Hiram Percy Maxim is calling to order the first meeting of the Radio Club of Hartford. Twenty-three charter members are present.

March 9th sees a banner attendance of 35.

Amateur radio is booming!

TRADITIONAL - a Man with an Idea. Mr. Maxim had the idea. With the limited ranges of the transmitters of that time, he forsaw the necessity for relaying, if messages were to be sent over great distances. But a relay network demanded organization - and there was no organization. Yet he had seen the Radio Club of Hartford burgeon into real significance in three short months. If a local organization of radio amateurs could prosper, so could a national organization. It would have to have some community interest to make it cohesive. Regular meetings were out of the question - but the relay idea would supply the common interest, with each member doing a service for each other member!

He told the club about his idea. He suggested a name for the organization - the American Radio Relay League. A Relay Committee was appointed. Application blanks for relay stations were printed. This was in May. By June they were under way. On June 15th and sum of \$50 was voted appropriated by the club for national development. By letter and by radio the word was spread.

The amateurs of the nationa hailed the idea with "eagerness and enthusiasm. . ." Minutes of the Radio Club of Hartford.

In October the League's first call book was published, a list of 400 stations in 33 states and Canada.

Amateur radio was booming!

In January, 1915, the American Radio Relay League outgrew the local control by the Radio Club of Hartford. Administrative control was taken over by Mr. Maxim and Clarence D. Tuska, its first secretary, and the League was incorporated under the laws of the State of Connecticut as a non-commercial organization with no capital stock.

## TWENTY YEARS OF AMATEUR RADIO CONTINUED

In March 1915, a second call book was issued, listing nearly six hundred members. By radio and correspondence strenuous efforts were made to build up relay routes throughout the atry. Yet it was difficult to make progress. It was too great a task to acquaint the membership with the progress and plans of the league through correspondence alone. Some form of bulletin becamse absolutely essential. The league, however, had no funds; membership was free, and the call books were sold at cost.

Then, in December 1915, came QST. . .

... "published by and at the expense of Hiram Percy Maxim and Clarence D. Tuska. Its object is to maintain the organization of the American Radio Relay League and to keep the amateur wireless operators of the country in constant touch with each other."

# SPECIAL ACTION BULLETIN (FROM 220 Notes)

NOW is the time for YOU to take some action to save 220 MHZ for Amateur Radio! You've read in the February issue of 220 NOTES, in QST, in Ham Radio Report and elsewhere -- that the FCC has proposed sharing 220 between Amateur Radio and a new Maritime Radiotelephone Service. We would be SECONDARY to the new Service. In other words, if you live near a body of navigable water, and your signals interfere with theirs, you close down. It's as simple as that,

The FCC can be persuaded to reconsider its proposal before presenting it to the World Administrative Radio Conference this fall in Geneva. What's needed is a flood of comments from hams, urging FCC to keep 220 for the exclusive use of Amateur Radio.

We have sent our own comments (as individuals) to FCC. NOW is the time for YOU to do the same. You will find, on the enclosed page, a suggested form for your own comment on the matter. This was prepared in consultation with Barry D. Bayer, K9CFV, of the law firm of D'Ancona, Pflaum, V tr and Riskind. You should do one of the following:

1. Sign and date the (sample) letter and send 14 copies to the Secretary of the

Federal Communications Commission, or ....

2. Sign and date the (sample) letter and send just one copy to the Secretary of the FCC, or . . .

3. Look over the points made in the (sample) letter, draft your own letter in your own words, and send 14 copies to the Secretary of the FCC, or

4. Draft your own letter, sign it, and send it to the Secretary of the FCC (one copy).

Fourteen copies is the best form, but one copy will still put you on the record as being in favor of Amateur Radio on 220 MHz exclusive. In any event, send a copy to Senators Percy and Stevenson (Illinois), or to your own Seantors, and to Congressman Martin Russo.

Also, send a copy to David Summer, KIZZ, at ARRL Headquarters. And let 220 NOTES know what you're doing, so that we can publicize it here.

But DO IT NOW! 73 -- Don't let them take 220 MHz away!

Re: In Support of the Petition of the 220 MHz Spectrum Management Association of Southern California, for Reconsideration of Portion of Report and Order Docket 20271

I am a licensed Amateur Radio operator assigned the call sign indicated hereunder. I actively operate in the presently-allocated 220 MHz amateur band, using my own equipment and through repeaters representing substantial investments of cash and technological effort.

In a portion of Docket 20271 (Par. 103 and 124) concerning its position to WARC on frequency allocations, the Commission proposed the present 220-225 Mhz Amateur Radio frequencies be allocated primarily to a new use by the Maritime Radio Telephone Service.

I am not aware of any Notice previously issued regarding this proposed allocation. This portion of the Report and Order clearly affects my rights and the rights of other licensed Amateur Radio operators to the 220 MHz band. A formal opportunity for Amateur Radio response would demonstrate that the 220-225 MHz band is in active use throughout the United States, presenting an attractive alternative to the crowded 2 -meter band.

Growth of "220" had previously been restricted by the threatened allocation of the frequencies to Citizen's band use. However, since the Commission denied that proposal, amateur use of the band has flourished.

I join with the 220 MHz Spectrum Management Association of Southern California in its petition to withdraw the affected parts of Docket 20271, and to set that matter for comments and hearings in an appropriate framework as required by law.

## SAMPLE LETTER TO YOUR CONGRESSMAN. Submitted by Joe Gardocki, K3NHW

In part of Docket 20270 (p. 103 and 124) concerning its position on frequency allocations, the FCC proposed to the WARC (to meet in Geneva in fall of 1979) that the present 220-225 MHz Amateur Radio frequencies be allocated for use by Maritime Radio Telephone Service.

We feel this would be very unfair; many hams have a lot of equipment used for communication on this band, and this represents a great deal of personal money and time expended as well as enjoyment and community service.

Please use your influence to see that this portion of the Docket is withdrawn — there are plenty of other frequencies for this maritime radio use. I understand that a group known as the 220 MHz Spectrum Management Association of Southern California has already forwarded a petition to reconsider this part of the Report and Order Docket 20271. I am totally behind their efforts, as are many other radio amateurs I have talked to over the country.

# GLENSIDE LANDMARK DISAPPEARS AS PENNARC RELOCATES TO MONTCO

For the past ten years, the home of the PENNSYLVANIA ANATEUR RADIO CLUB (PENNARC) A3RCA) has been marked by the sixty foot radio tower in the rear of 111 S. Easton Road, Glenside, next to the Continental Bank parking let. This is also the residence of Peter H. Shavney who founded the radio club in September of 1970. Many thousands of messages have been exchanged via the antenna systems on top of the tower (since sold to K3LOM) with other amateur stations in all fifty states and over one hundred foreign countries. PENNARC also sponsors Explorer Post 211, BSA (Valley Forge Council), the only ham radio Explorer Post in the Delaware Valley. The post will continue to meet at Pete's QTH for the foreseeable future using radio gear provided by WA3OVH. PENNARC had become well known for its handling of the annual Christmas Hospital Message Service for bedfast patients stuck in area hospitals over the Christmas Holiday and in past years has been shown on several local television stations. Lee Cohen who originated the service continues to provide this service assisted by a large number of local hams.

Other highpoints in the club's history occurred in 1973 when eight members and a trailer load of emergency equipment were dispatched to Wilkes-Barre for five days to assist with local communications in the aftermath of Hurricane Agnes. Telephone service had been wiped out in the city and emergency portable communications were the only way to meet the needs of thousands of evacuees made homeless during the flood.

In 1975, PENNARC was requested to operate the National Boy Scout of America Station, K2BSA in North Brunswick, N.J. during the annual Jamboree on the Air as their facilities had been damaged by high winds. Another trailer load of equipment and members were again dispatched this time including one of the club's portable fifty foot antenna towers. Over two thousand radio contacts were made with other Scout stations from all over the world, and the Jamboree was a great success.

Both communicative and technical skills of the radio club are kept sharpened by participating as a group in frequent radio contests and communications exercises such as the annual FIELD DAY in which the members will take part June 23 and 24th this year atop Valley Forge Mountain using ground and facilities provided by the University of Pennsylvania. The public is cordially invited to attend the exercise. Information may be obtained by writing the above address.

However, as club membership expanded during the past ten years, it became increasingly difficult to hold meetings at Shavney's home. Following an extensive search throughout Eastern Montgomery County, an agreement was reached with Montgomery County Community College on Route 202, Center Square, Pa. and in the new future, local residents will once more see the world wide antenna systems of the Pennsylvania Amateur Radio Club on top of Montco's Founders Hall, beaming radio messages across the country and around the world.


