THE HERB ZEIGLER STORY From September Issue, "FLORIDA SKIP"

(Editors' note; We know this belongs under "Digesting the Mail", but we decided to give it a place of honor.)

On June 15th an automobile roared out of the night.

It struck a man down and roared away. The night seemed to have swallowed it up. The subsequent search has failed to locate the car or its driver.

The brief seconds of impact left Herb Zeigler, K4LCF, New Smyrna Beach, a heap of crumpled and broken bones lying in the street.

It touched off a story of courage and devotion by all Herb's friends as the news flashed out over the amateur frequencies.

Zeigler had left the American Legion Hall that night heading for his car. Only a **Pew** days earlier, he had been elected commander of the Legion Post.

He wore the uniform of the Florida Highway Patrol Auxiliary,, in whose ranks he served.

Minutes later, his doctor was battling to save his life,

Herb's friends, were stunned over the hit-and-run accident but recovered more quickly than did Herb, and a flood of sympathy poured forth and engulfed the young man (sorry we cannot reproduce his picture) and his family.

During the first 10 weeks of his hospitalization over 200 QSL cards, letters, and notes of good will came to his room.

The gifts of flowers and plants were so numerous that the medium sized hospital room could not begin to acommodate them.

Today, over four hundred get well cards dot the walls of his room, pinned there by nurses to cheer him up in the event he ever feels no one cares.

But the aid did not confine itself to cards and flowers. Financial and spiritual help also came forth and Zeigler's friends gave of their blood,

At the height of his medical crisis, when his doctor fought to push back the shadows seeking to envelope him, Herb's friends donated 18 pints of blood.

His fellow workers, and supervisors at Owens Bros. Concrete, split up his duties so they could avoid hiring a replacement and could continue to pay Herb his salary.

Herb, as he contemplates the future now, is cheerful and optimistic. He figures just being alive puts him ahead of the game.

His gratitude to his friends, his associates and his doctor, Thomas D. Cook, is touchingly, almost embarressingly, sincere.

He seems to believe, and who can doubt him, that the wall of good wishes and community concern which surrounds him, convey a tonic effect which will help pull him through.

He came to the hospital with two broken legs, a shattered pelvis, bones broken in his back and with serious internal injuries. Complications, infections, extensive bleeding followed.

At one point, a short time ago, he broke two more ribs just turning over in his hospital bed.

For Herb, a good looking trim young fellow, the months of pain and suffering have been interminable.

Now he is able to sit up daily and his wife is permitted to wheel him about the hospital corridors and lobby in a wheel chair. It doesn't sound like much for an athletic man but it's a long way from the shattered heap of bones lying in front of the American Legion Hall.

Herb knows other long weeks await him. Weeks when he will be bound up in the cumbersome casts which restrict his every movement.

But he's smiling and cheerful. And his faith is not debatable. He wears the look of a man who knows he has friends.

Herb had just completed a new QTH before his accident and neighbors and friends have moved them into their new home. Case, W4NGR and others moved Herb's rig and now all that remains is to put up the antennas.

KAVNA, WANRE, KACJE, WAFIM and others have volunteered to take care of this.

Knowing the financial burden would be tremendous, a group of hams started to send help to Herb and in a short tim \$158 was deposited in Herb's account. However, a group of Herb's friends have gotten together to see if a substantial bit of help could be obtained. With the help of Florida Skip, it is planned to offer certain items of printed gizzmos which might appeal to hams for their own use or as gifts.

(Ed. note; Never did find out if El's neighbor got rid of the interference but he attended the "Pack Rats" Picnic with his small son.)

Here is a very recent correct TVI complaint.

Sunday afternoon, September 23, while Frankie was checking out a 6 meter transmitter for one of the Rats; the front doorbell rang. I answered it and a man asked me if my husband was I said, "Yes." He told me that he was interfering: with his TV and spoiling his viewing the Giants-Eagles Football game, and just wanted to know if anything could be done to stop it. He asked if he could talk to Frankie and I told him certainly.

As he came thru the door, I asked him if he had ever heard him before, and he said, "No." I then explained that Frankie was not using his transmitter but checking another fellows.

He went up to the shack and told the OM his problem, and asked what could be done.

Of course the first question Frankie asked was,"What channel?" He replied, "Channel two." Frankie then explained to him, that Channel two was considered a fringe station by the FCC in. the Philadelphia Area, and that the hams in this area were only responsible for the local channels. We also told him that he had nothing to lose by writing to the manufacturer and explaining the situation and ask for a high-pass filter.

Before leaving, he thanked them for the information, and they thanked him for letting them know.

The following is a copy of a mimeographed explanation which the FCC sends to all complainants.

TELEVISION INTERFERENCE FROM AMATEUR RADIO STATIONS

(The conditions outlined below also apply to Citizens Radio Stations)

Interference to television reception by amateur transmitters may be caused by either improper adjustment of the transmitter or by the receivers in-(next page)

ability to exclude stations not operatine on the television channels. Inability to exclude signals which are not on the television bands is frequently found to be a receiver fault not ordinarily suspected until a nearby transmitter presents the test.

Amateurs are licensed by the Federal Communications Commission for operation on specified frequency bands. These frequency bands do not overlap the television bands. However, transmitters often radiate appreciable amounts of harmonic energy, which may fall in the television bands. If this condition exists, the amateur will be required to reduce the strengh of these harmonics to an acceptable value.

To determine whether the television receiver or the amateur transmitter is at fault, it is merely necessary to observe the amateur's own television receiver for freedom of interference while his transmitter is in operation. This test is gererally more difficult for the amateur to pass than for the complainant, since his transmitting antenna is usually closer to his own television receiver and his signals are stronger at this point.

If the interference is due to improper adjustment of the transmitter, which is radiating an undesired signal on the television bands, the amateur's television receiver will be subjected to interference, as will all other television receivers within range. Such a condition requires correction at the amateur transmitter. Absence of interference in the amateur's television receiver indicates that his transmitter is not radiating in the television channels.

In order to determine which equipment is at fault, arrangements should be made by the complainant to view the amateur's television receiver while he is operating his transmitter. If interference is observed in the amateur'S television receiver at the same time. that the interference is received in complainant's receiver, this would indicate that the amateur is at fault; and he must take steps to correct the difficulty. On the other hand, if the amateur's television receiver is free from interference at the same time that the complainant's receiver gets the interference, the fault is with the complainant's receiver and should be referred to the manufacturer for such corrective action as he will furnish.

Before making the above test, the complainant should carefully examine the pattern of the interference seen and/or heard in his television receiver. Note the channels interfered with. Note particularly the pattern of the interference on the television screen, the thickness and arrangement of the interfering lines; their direction of movement, if any, and the extent of any distortation. The presence of these interference effects during the abovementioned test is your guarantee that (next column)

the amateur transmitter is being operated in exactly the same manner prior to the test. Unless these interference offects are present during the test, it is of little or no value.

RCA Nuvistor Triode 8058, a double ended type for use in GG circuits. The grid connection of this nuvistor is made to the metal shell. This means that the grid is well grounded when the unit is plugged into the socket. (be sure to clean the indexing lugs!!!) Three pins are used for the cathode connection. A ceramic cylinder is used to isolate the plate cap on top, so that it looks like the Tetrode 7587. Experiments by W2VCG indi-. cate that the 8058 is completely stable at 432 in GG operation, whereas the 6CW4 used in the 1962 ARRL Handbook 432 Mc converter was prome to self oscillation. NAVY UNVEILS MARS RADIO PLAN FOR HAMS

WASHINGTON -- Rear Admiral Bernard F.
Roeder, Director of Naval Communications
disclosed plans last week to establish
a Navy Military Affilia te Radio System
(Navy MARS) similar to existing Army
and Air Force MARS.

The Navy MARS will emphasize training of amateur radio operators in Navy Communicatios procedures. Officials said that in this way Navy-oriented hams will be able to maintain an affiliation with the Navy, and will provide a source to fill specific mobilization assignment of trained operators for use in a local disaster situation or a general emeracine may or may not be amateur.

The operators, many former Navy personnel, will generally operate from their own amateur stations with assigned call signs. They will ahndle message traffic of a morale nature -- traffic that does not qualify for regular transmission over Navy circuits.

The program will be administered and o operated from the Naval Communications System and the Naval Reserve Communication System. The latter is a training network for Naval reservists in a drill status and also can be used in emergencies.

Interested hams may obtain further information about the program from the director, Navy MARS, office of Naval Communications, Pentagon, Washington, 25, D.C.

MILITARY AFFILIATE RADIO SYSTEM - NAVY STYLE:

Received from Mr. Charles T. Garland, Head, Technical Information Branch Office of Naval Communications (OP-945Y) Navy Department, Washington, 25. D.C. (Received by W8BAH, AREA Sec. September 11, 1962)

"In November 1948, the Secretaries of the Army and Air Force established a MILITARY AMATEUR RADIO SYSTEM for their respective services by a joint directive. The name was changed to the present Military Affiliate Radio System (MARS) in September 1952. The Navy had statted its postwar Volunteer Reserves in 1946, and therefore, did not subscribe to the new MARS program.

Since neither the Army or Navy could return to their prewar Army Amateur Radio System (AARS) and Naval Communications Reserves (NCR) operations in the amateur bands, these two new programs were established as military circuits using frequencies as assigned by many changes and evolved as the present organization of the Intra and These Naval Reserve circuits grew further away from the amateur radio operations, and while Naval Reservists were, and are, encouraged to participate in amateur radio activities. there is no requirement for their holding an amateur ticket. The Naval Reserve Networks are designed and operated to train obligated personnel ments. Participants of the Reserve circuits are Naval Reservists first and may or may not be amateurs.

....The possibility for an auxiliary network that could provide an unparalleled capability for the survivability of a Naval Communication System during periods of local, national, or inter-national emergencies, plus the chance to create a potential input of personnel into the Naval Communication System while providing a means for the HAMS with salt water in their system to amintain their Navy proficiencies, led the Director of Naval Communications, Chief of Naval Operations, and the Secretary of the Navy to the conclusion that the time was ripe for a NAVY MARS. Therefore, on 17 August 1962 the Secretary of the Navy approved a CNO request for authority to establish a Navy MARS. This decision was announced to the amateur world by Rear Admiral Bernard F. Roeder, the Director, Naval Communications during his speech before the Twelfth Annual National American Radio Relay League Convention in Portland, Oregon, on 3 September, 1962.

NAVY MARS (cont'd)

The target date for the implementation of the MARS program is 1 January 1963. At that time the MARS headquarters station NAV/K4NAA will commence operating from the old NAA Navy Radio, Arlinton site. This site is presently occupied by the National Naval Reserve Master Control Radio Station. (NCR)

....At this stage, the details of manual writing, instructions preparation, frequency problems, and coordination necessary to effectively implement this program are being confronted. Further information will be released as soon as it is available. In the meantime, comments and suggestions from any of the 244,000 licensed amateurs in the United States and from Naval Communicators everywhere, are invited.

.... Special call signs for NAVY MARS will be NØRAA thru NØZZZ.

UN WEEK


Once again, as in the past two years, the Delaware Valley Council of Amateur Radio Clubs will participate in the celebration of UN WEEK, OCTOBER 21 to

Canadian amateurs may now handle third party traffic with amateurs in Honduras and Mexica. That is, the messages must not be of sufficient importance to justify public communications services and there must be no direct or indirect financial compensation.

RE: ENVELOPES FOR SELF-MAILERS.

I inquired where such a rumor might have originated. They said that at one time there was such a regulation in a bill before Congress but that it was not in the present bill. So there we are.

This thing breaks down when you analyze it --- If one uses precanceled stamps or permit imprint those papers NEVER TOUCH a machine anypiace. fact, since the papers are bundled, they stay in a bundle until they roach their final destination. Since they bear no stamps there is no cancelation.

Thanks, Andy, but all I know is that the article very definitely stated that self-mailers would be banned after Jan. 1, 1963. A self mailer is a flier or publication which is folded once or twice and either stapled or taped shut. It is called a self-mailer because it is not in an envelope.

I checked with the Post Office before reprinting the article in "Cheese Bits"

All I can say is, we had all better keep a check with the Post Office as Jan. 1, 1963 rolls around.

TELEPORTATION ON THE HAM BAND:
