# REPORT ON THE SPECIAL MEETING, FRIDAY EVENING MAY 1, 1959

At our special meeting on Friday evening May first, held in the conference room at the Naval Aviation Supply Depot, 700 Robbins Avenue, we had the privilege of welcoming 31 guests. Our Speaker was Mason P. Southworth, WIVLH, Project Supervisor of the ARRL IGY Propagation Project. Aside from Mason, W3ASD. Karl, traveled the fartherest to attend. 80 some miles.

Among our guests was a father and his son, non-hams, who heard about the meeting from a ham in Mt. Airy, and since his son is interested in radio, he brought him to the meeting.

Altogether with guests and members, we had a crowd of 55. Wo consider this a good crowd to get for a special meeting on a Friday evening, especially since Friday evening is usually shopping night for most people.

After first discribing what the project was all about, and showing pictures of the work that the staff did, Mason then proceded to illustrate the Propagation findings.

It was a little Greek to me, but I know that the hams understood all about the F2 Layer, the effect of sunspots and arora's on the transmitting and receiving signals. The different peaks that cause different kinds of back-scatter. How, on certain openings, reception was better for DX, sometimes beam-to-beam, off the side or off the back of the beam, and how sometimes the only means of reading a station was by cw.

One illustration was a map showing the locations of propagation stations, and it was very noticable that there were no stations in Russia. It seems that none of the propagation stations heard Russia coming through quite consistantly around 55.3 mc with the beams to the Northeast, around 9:00 P.M. We told Mason about it and he said that it was the first time that he heard about it. This was reported in an earlier edition of "Cheese Bits", in fact the members of the 6 meter net took time out one Monday night to check on it. At first they thought it was a breakthrough from another band, or a rebroadcast; but when everyone heard it, they knew it was Russia.


Mason also showed us copies of the certificates that were sent to the propagation stations. We had two such stations present;  $\mbox{W3ZRR}$ , Ray, of Mt. Airy Radio Club, and  $\mbox{W2EIF}$ , Joe, from South Jersey Radio Association.

After the talk and illustrations a question and answer period was conducted. One of the questions asked concerned the cw segment for 6 meters. Mason stated that he could not answer for the ARRL, but that he could answer about cw from reports of the propagation station operators. Most of them reported that if it wasn't for cw in the low end of the band they would have missed quite a number of DX stations, especially with weak signals.

(Editor's note: For the ARRL's opinion on  $c\omega$  segments on the low end of the 6 and 2 meter bend, see page 84 of May QST.)

After the meeting, W3CH, Harry, W3JSO, John, W3FQD, Dick, W3CPT, Ken W3HKZ, Ed and W3SAO, Frankie, myself and the Jr. Op. went out with Mason for a bite to eat. While there we learned that he would be in the vicinity until Monday May 4th, when he was leaving for Washington, D.C. From Washington he is leaving for Stanford University in Pale Alto, Colifornia, and will be there for two years. We promised to keep him up to date on any special DX that we come across. (P.S. While eating the Jr. Op. put his head on his arms and went to sleep, and the next night started with Scarlot Fever.)

We would like to thank the ARRL for sending Mason, and thank our many friends who took the time to attend the meeting.

Responsive to the FCC proposal in Docket 12728, the League's Executive Committee conducted a mail vote of the Board of Directors with the result that ARRE policy has been established supporting the proposal to permit Technicians to use the 144-Mc. amateur band. The pertinent text of the League's filing follows:

PETITION FOR RECONSIDERATION

COMMENT OF THE AMERICAN RADIO RELAY

LEAGUE, INC.

Pursuant to paragraph 9 of the notice of proposed rule-making in Docket 12728. The American Radio Relay League, Inc., files these comments on behalf of some 70,000 FCC-licensed amateurs who are members of the League.

The Leauge supports the proposal to permit operating privileges for Technician Class amateur operators in the 144-148 Mc. amateur band. We agree with the Commission's conclusion that several of the pertinent considerations have undergone changes in the four years since a similar proposal was dismissed, largely at our request. The League feels that, in general terms, the arguments set forth are valid and meritorious.

BFFICIAL BULLETIN NR 701 FROM ARRL HEADQUARTERS, WEST HARTFORD, CONN.

APRIL 30, 1959

TO ALL RADIO AMATEURS BT.

Responsive to ARRL and other requests in Docket 12485, FCC has reopened the question of cw segments in the 6 and 2 meter band. FCC now solicits by August three specific constructive comment in favor of or against its original proposal to establish 100 kc cw segments at the low end of each band as proposed by the League. FCC indicates it has little interest in postcard type ballots or other yes and no expressions but wants viewpoints adequately supported by specific arguments.

The League's petition for reopening the question appears in May QST starting on page 84. Read it, and then if you wish to file a comment, write a letter, not a postcard, to the FCC stating your views and reasons for or against.

This summer the FCC will hold hearings concerning allocations in bands from 25Mc to 890 Mc. All interested parties are submitting their plans now, some are advocating sweeping changes in nearly every service including deleting TV channels 2 to 6, deleting some ham bands and shifting some ham bands. The following is what Motorola, Inc. is submitting to the FCC. Motorola is pushing for a great amount of land frequencies, including all of the 6 and 2 meter ham bands. (Motorola makes land mobile equipment). Motorola suggests putting land mobile from 50 - 72 Mc and shifting the 6 meter ham band to 72 - 76 Mc. They also want land mobile on 140 - 166 Mc and shifting the 2 meter ham band to 136 - 140 Mc with 136 - 138 ham frequency shared with space communication. They also want to put all TV on 174 - 354 Mc.

(Editor's note:) I don't know how you boys feel about Motorola's plans, but I for one, feel that you should all write to the ARRL asking them to go to bat for you to prevent it. After all the FCC allocated your frequencies before TV, and you can be sure that CBS, NBC and ABC are not going to sit back and do nothing about it. Should Motorola's plan be accepted and TV channels and frequencies be changed, then your TV set will be obsolete. You will either have to put a converter on it. or buy a new set. You don't buy TV sets for \$1.00. Think it over, and I am sure that you will write to the ARRL, or FCC, not only to protect your rights as a ham, but also to protect your pocketbook.

RACES and AREC are set up on the frequencies that Motorola advocates doing away with. You can see that they are not just bucking the hams, but also the Eivil Defense and Moblization of the Federal Government.

\_\_\_ \_\_\_

The Navy is going to construct a transmitter in Washington, D.C. to communicate directly with Hawaii, via the Moon. Eventually the Navy expects to be capable of transmitting 188 to 208 simultaneous radio teletype signals back and forth from Hawaii. Point ot point UHF transmissions reflected off the moon are limited to line of sight angles between the trans mitter and receiver. 13 stations. The passage of the moon in it's orbit necessarily confines communication to the relatively short period. when the satellite is in 'View' of both stations. It is expected to be available from 5 to 7 hours a day.

The transmitters will use klystrons developing 170 Kw at a frequency above 500 MC. The klystron tube is 10 feet high and costs about \$20,000. Practicalty of lumar UHF communications has been demonstrated between Alaska and California, a lateral transmission of 2,200 miles. A steady 2 hour signal անձ picked up by a 39 foot parabelic antenna, with a delay of  $2\frac{1}{2}$  seconds, klystron generated power was estimated at 20 million watts. Signal power received: on a bandwidth of 100 cps was said to be5x10 watts to the minus 17th power. It is envisioned that trans—Atlantic TV transmissions via lunar reflection will be acheived in about 5 years,



The ARRL Board of Directors met May 15 in Annual Session at Hartford making a careful examination of league participation at the International Telecommunications conference to be held in Geneva, Switzerland beginning in August. General Manager, Budlong, W18UD, and assistant General Manager, Huntoon, W1LVQ, will be members of the United States delegation. Canadian Director, Alex Reid, VE2BE will attend as a member of the Canadian delegation. The League's President, G.L. Dosland, WATSN, Technical Director, George Grammer, W1DF and General Counsel, Paul M. Segal will be available as required.

The Directors revised the By-Laws to set the Annual ARRL Membership Fee, starting August one, 1959, atfive dollars in the USA with five dollars twenty —five cents for Canadian members.

The housing committee will continue to explore possible new buildings for League Headquarters. Vice Directors in the future will serve as Director at any Board meeting where the Director is unable to attend. Directors John G. Doyle, W9GPI, Morton B. Kahn, W2KR, and Milton E. Chaffee, W1EFW were elected as members of the Executive Committee.

Customary funds were continued for travel reimbursements of ARRL Field Officials and the mileage allowance for travel was raised to eight and one half cents per mile. The Board extended its thanks to SCM's, SEC's and QSL Managers for their services and approved a National Convention at Portland, Oregon for 1962.


